RULES AND REGULATIONS

1. All standard varieties will be accepted for entry and the Standard of Perfection will govern all awards. No prizes will be paid on cross breeds and hybrids.

2. Old and young stock will compete separately. No pen or trio entries will be accepted.

3. All purebred pet stock such as rabbits and pigeons will be accepted for entry and prizes will be paid.

4. All animals will be promptly fed and watered by the owners. All specimens will be entered at the risk of the owner. The superintendent may reject any exhibit deemed detrimental to the exhibition.

5. 4-H and FFA exhibitors may enter birds in these classes but must show separate birds than those shown in 4-H and FFA classes.

6. Effective January 1, 1963, all poultry, except water fowl and pigeons, must be negative to the rapid whole-blood plate test for pullorum and typhoid diseases applied within 90 days prior to the opening date of exhibition, provided that no test shall be required on poultry originating directly from parent stock tested and found negative within the preceding 12 months. An officially recognized form signed by an authorized agent must be presented to show compliance with this section. Official forms from other states shall be approved by the official agency of state of origin, recorded on the official form.

Premiums for single entries: 1st \$2.50; 2nd \$2.00; 3rd \$1.50.

GENERAL RULES FOR FFA DIVISION

1. Only bona fide FFA members of Lac qui Parle Valley FFA, Benson FFA, and KMS FFA can exhibit or show thru age 21 years. Eighth graders will be eligible if they are in an accredited summer program. 1 Blue, 1 Red and 1 White will be given for livestock.

2. Each member will be limited to one entry in each individual lot except livestock in which they will be limited to two entries win each individual lot, only one entry in group lots.

3. Only purebred animals registered in the members name or jointly may be show in sire classes; good grades may be shown in all female classes.

4. Only animals which are projects of members and on which records are kept as certified by their FFA advisor can be exhibited in FFA classes.

5. All entries for FFA must be sent to your FFA advisor by 1:00 p.m., first day of fair. Exhibits entries must be mailed to arrive by deadline date if you are to reserve pens.

6. All livestock brought on the fairgrounds must comply with rules and regulations of the Minnesota Livestock Sanitary Board. Check with your FFA advisor or the County Agent.

7. FFA livestock will be judged as per schedule included in posted schedule.

8. Classes of 11 or more will be split.

9. Exhibits will be released at 8:00 p.m. Sunday.

Division FFA – Crops

CROP RULES

1. Only one entry per lot. Additional entries must be individual FFA projects as certified by the FFA advisor.

2. Corn shall be 2007 crop.

3. Small grain – 2007 crop – 2 quart samples.

4. Soybeans – 3 inch diameter sheaf, 2008 crop; 2 qt. sample, 2007 crop.

5. Sunflowers – 2008 head; or 2 qt. sample 2007 crop.

6. Hay shall be shown as a 12-inch section neatly tied.

7. Silage will be shown as 1-gallon sample in sealed, clear plastic bag.

8. Members must specify VARIETY on all small grain and soybean entries.

9. All entries due by 1:00 p.m. first day of fair.

10. Small grain sheaves will be shown without roots except soybeans.

The awards will be paid on the following sliding scale:

1-5 Entries.....4.00 3.50 3.00 2.50 2.00

6 and over.....5.00 4.50 4.00 3.50 3.00

.....2.50 2.00 1.50 1.00 1.00
